## Terms & Conditions

Any part of the vehicle that falls off during transport is the customer's responsibility, including damages by said part to any and all vehicles involved.

The customer is responsible for completely disarming any alarm systems. The customer must provide keys or remotes for any alarm system. In the event that the car alarm sounds, the transporter is required to silence the alarm by means he deems reasonable and effective.

Your Company Name will not be responsible for any mechanical or electrical functions, leaking fluids, and exhaust systems.

Your Company Name will not be responsible for radio antennas that do not retract no more than 3 inches above the hood or fender of the vehicle being transported.

The customer agrees that should this vehicle become mechanically inoperable for any reason during transport through no fault of ours, repair costs will be added to the transport fee to be collected at the time of delivery.

The carrier will not be responsible for convertible tops that are loose, torn, or have visible wear. The transporter will also not be responsible for vehicle boots, caps, masks, bras, or any other type of canvas or material covering.

All payments for transport must be in the form of cashier's check or cash on delivery. The customer agrees that if the payment cannot be made by cashier's check or cash, the vehicle will be stored at the customer's expense. Should the customer be unable to accept delivery for any reason, the vehicle will be placed in storage. Any and all storage and/or delivery charges will be the responsibility of the customer.
